THIS IS A LEGALLY VALID AND BINDING OBLIGATION TO RELEASE THE BICYCLE RENTER FROM ALL KNOWN OBLIGATIONS, AND TO INDEMNIFY THE BICYCLE RENTER AGAINST CLAIMS BROUGHT AGAINST IT BASED UPON YOUR USE OF THE BICYCLE. THIS INSTRUMENT AFFECTS IMPORTANT LEGAL RIGHTS FOR RENTER AND RENTEE.

Release and Waiver of Claims: For valuable consideration, the receipt and sufficiency of which are hereby acknowledged Renter does hereby remise, release, and forever discharge THE BIKE HUB, THE BIKE HUB'S agents, servants, successors, heirs, executors, administrators and personal representatives, of and from all, and all manner of, actions, causes of action, suits, proceedings, debts, dues, contracts, judgments, damages, claims, and demands whatsoever in law or equity, which Renter ever had, now has, or which Renter's heirs, executors, administrators or personal representatives hereafter can, shall, or may have for or by reason of any matter, cause, or thing whatsoever arising out of this Agreement; out of the use (misuse, or abuse) of the bicycle; or in any way arising out of the rental relationship between Renter and BIKE HUB

<u>Indemnification</u>: For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Renter hereby expressly agrees to indemnify and hold harmless **THE BIKE HUB & THE BIKE HUB'S** agents, servants, successors, heirs, executors, administrators and personal representatives against all suits, actions, claims, demands, or damages that arise out of Renter's use, misuse or abuse of the bicycle.

## **Terms and Conditions**

1. <u>Assumption of Risk.</u> Renter acknowledges that the activities for which the bicycle is designed include inherent dangers, including the risk of bodily injury and/or death. Renter assumes and accepts all risks associated with the use of the bicycle. The Bike Hub is NOT responsible for road hazards and CANNOT provide assistance. Call 911



- 2. <u>Acceptable Use.</u> Renter agrees and acknowledges that he/she will be the sole operator of the bicycle, and will use the bicycle in a careful, safe and conscientious manner. Renter shall at all times observe and adhere to any rules and guidelines posted by **THE BIKE HUB**, and any applicable laws or regulations.
- 3. **Prohibited Activities**. Renter shall not violate any of the following rules and regulations during his/her operation of the bicycle:
  - There are **no passengers** permitted on the bicycle unless expressly permitted by **THE BIKE HUB** in writing prior to use and there are no modifications of rented bicycle permitted.
- 4. <u>Unsafe Use.</u> If at any time **THE BIKE HUB** determines that Renter has engaged in an unsafe or hazardous use of the bicycle, **THE BIKE HUB** may immediately terminate the rental. Upon notification of termination, Renter must return the bicycle to the designated return area immediately. If the rental is terminated for unsafe or hazardous use, Renter will not be refunded his/her security deposit. **THE BIKE HUB** shall determine, in its sole discretion, whether any behavior or activity is "unsafe or hazardous." Helmets are provided with bicycle rental and are required by law.
- 5. Condition of Bicycle upon Return. The Renter shall return the bicycle to the designated return area clean and in the same condition as it was in when given to Renter, excepting ordinary wear and tear. Renter shall be responsible for any damage caused to the bicycle during the rental period. THE BIKE HUB shall retain any portion (or all) of Renter's security deposit as necessary to cover repairs for such damages. To the extent that damages to the bicycle exceed the amount of the security deposit, Renter shall be billed by THE BIKE HUB for the full amount of damages caused by Renter during the rental period, including reasonable attorney's fees.

  DIRTY BIKES MAY INCUR A \$25 CLEAN FEE DETERMINED AT DROP OFF.
- 6. <u>Late Return.</u> If Renter returns the bicycle to the designated return area more than 20 minutes after the scheduled "Time Back," Renter shall forfeit his/her security deposit
